- **a. LSTA Grant Received:** Beth Bogaert presented information about the LSTA grant the library received. Bogaert also provided information regarding grants the library has applied for and will apply for other grants as they become available.
- b. Library Budget for FY 2020-2021: Bogaert presented a budget to the board for the fiscal year 2020-2021. The board voiced concerns about the impact the COVID-19 pandemic may have in the future on funding and the budget. Bogaert will present a revised budget at the June meeting.
- **c. Staff Salary Increases:** Bogaert provided a salary increase proposal for library staff. The board discussed possible adjustments that need to be made to account for any funding decreases due to COVID-19 pandemic. Bogaert will present a revised salary proposal at the June meeting.

VII. New Business:

a. Library Closure: The library remains closed due to the outbreak of COVID-19 per Governor Whitmer's executive orders. The Stay Home, Stay Safe order is set to expire May 28, 2020. Bogaert discussed with the board the plans in place to keep patrons and staff safe when the library can reopen. Bogaert also briefly discussed Families First Coronavirus Response Act (FFCRA) and furlough options.
